— TRANSFERABILITY OF ADDITIONAL UNITS

The transferability provisions in the Original Agreement apply to the Additional Units.

— JOINDER TO OPERATING AGREEMENT

By signing this Addendum, Investor confirms their agreement to be bound by the Company’s Operating Agreement as a Class B Member, including any amendments or updates made since the execution of the Original Agreement.

— GOVERNING LAW AND VENUE

This Addendum shall be governed by and interpreted and enforced in accordance with the substantive laws of the State of Nevada, without regard to any conflict of law principles. The sole and exclusive venue for any dispute shall be Clark County, Nevada, as provided in the Original Agreement and the Company’s Operating Agreement.

— INDEMNIFICATION

Investor agrees to indemnify and hold harmless the Company from any claims or damages resulting from any breach of the representations and warranties in this Addendum or the Original Agreement.
